Participants can come anytime during that period to decorate and make any changes they see fit. After September 30th at 5:00pm not changes will be allowed. Any scarecrow not completed by 5:00pm on September 30th will be disqualified.

- <u>Scarecrow Pick-up</u> will begin at 11:00am on Tuesday, November 1st and all scarecrows must be picked up by 5:00pm Friday November 4th.
 - Any scarecrow not claimed by 5:00pm Friday, November 4th will become property of Great River Entertainment LLC.

Prizes: 1st place: \$1,000, 2nd Place: \$750, 3rd Place: \$500. Checks will be made out to the business's chosen charity.

Scarecrow Guidelines:

- <u>GRE will provide 1 Scarecrow Stand</u>, consisting of a concrete-filled bucket and a 6' board acting as the backbone for the design. Groups are allowed to affix things to the board however they see fit, i.e.: staple, nail, glue, etc.
- Display area is approximately 4ft x 4ft.

- Each display area will be provided with one electrical outlet, if needed.
- Please refer to specific manufacturer guidelines when connecting multiple strands of lights.
- It is the decorator's responsibility to maintain all battery operation. Any scarecrow that has battery operated accessories must have someone in charge to turn them on/off and replace when needed.
- GRE staff is not responsible for setting up displays.
- Decorating of the scarecrows will begin Monday, September 26th at 10:00am. All scarecrows must be completed by 5:00pm on Friday, September 30th.
- Each group will have a labeled area for their display.

Decorating Guidelines:

- Scarecrows must be appropriate and family friendly. <u>No weapons, even fake, may be used in any part of the display</u>. GRE staff reserves the right to reject any entries at any time.
- All decorations must be secured. GRE holds no responsibility for damaged or broken decorations due to insufficient mounting.
- Scarecrows must be decorated to be viewed from all sides.
- Please do not use perishable items on or by the scarecrow or anything that could spoil or rot. No real pumpkins. Dried corn, gourds, etc. are accepted.
- A skirt or other appropriate covering for the base of the tree MUST be included with the design.
- Groups may place items on or around their scarecrow to enhance its display, but all décor must stay within their 4x4' display area.

Pick-Up Guidelines:

- Scarecrows must be picked up between Tuesday, November 1st and Friday, November 4th. Only
 the scarecrow & board may be taken all buckets will be left for reuse next year. Any
 scarecrows not claimed will become property of Great River Entertainment LLC.
- Winning scarecrows will be contacted by GRE staff to set-up a photo-op with the business and/or corresponding sponsored non-profit.
- In the event of a tie GRE staff will act as tie-breakers.
